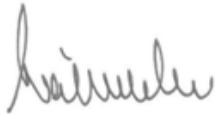

Destinations: As an Accreditation Body, GSTC places marks for certifying bodies that certify touristic destinations as sustainable. Additionally, to assist policy-makers at the national, provincial or state level, plus destination managers at the municipal level, which are always public sector, GSTC offers planning and capacity-building tools. For planning, we provide assessments of current situation with recommendations for future action. For capacity-building we offer multi-day training sessions for policy-makers.
