There are two sets: Destination Criteria for public policymakers and destination managers, and Industry Criteria for hotels and tour operators. These are the guiding principles and minimum requirements that any tourism business or destination should aspire to reach in order to protect and sustain the world's natural and cultural resources, while ensuring tourism meets its potential as a tool for conservation and poverty alleviation.

The GSTC is an independent and neutral organization, legally registered in the USA as a 501(c)3 non-profit organization that represents a diverse and global membership, including UN agencies, NGO's, national and provincial governments, leading travel companies, hotels, tour operators, individuals and communities – all striving to achieve best practices in sustainable tourism. It is a virtual organization without a main office, with staff and volunteers working from all six populated continents. Financial support from donations, sponsorship, and membership fees allows us to provide services at low costs and to create, revise, and make available the GSTC Criteria.

Membership is open to all interested parties and does not by itself imply endorsement by the GSTC of the policies and practices of the member organization.

Sustainability has been both a passion and a strong thread throughout her career, so she was delighted to take on the role as Travelife Commercial Director after returning to London at the end of 2017.



Jonathan Tourtellot Founder, National Geographic Center for Sustainable Destinations; CEO, Destination Stewardship Center

Journalist, editor, speaker, and consultant, Jonathan Tourtellot runs the nonprofit

Destination Stewardship Center.

During his three-decade career as a senior editor with National Geographic he wrote about travel, geography, the environment, and science. Using structured crowd-sourcing, he instituted National Geographic's Geotourism MapGuide program and the landmark Destination Stewardship surveys reported annually in National Geographic Traveler, 2004-2010.

A longtime member of GSTC's Destinations Working Group, he helped with formulation of the Destination Criteria. He originated the concept of the geotourism approach, put forth by National Geographic as "tourism that sustains or enhances the geographical character of a place—its environment, culture, aesthetics, heritage, and the well-being of its residents."

He is the primary author of the Geotourism Charter, a set of stewardship principles adopted by assorted world destinations and, in 2013, by the Organization of American States.



Jorge M.C. Alves Azores Destination Management Organization (DMO)

Jorge acts as the Coordinator of the Azores Destination Management Organization (DMO) and as an Advisor to the Regional

Secretary for Energy, Environment and Tourism at the Azores Government.

Before joining the Azores DMO, for 8 year he was the General Manager of Turangra Viagens Turismo, is one of major Tour Operator. Jorge also has an experience in the hotelier world as a General Manager of Hotel Holiday Inn Azores (NSL). He also serves as Administration Board Member of the Azores Youth Hostels (PJA, S.A.).

Julian Matthews Founder & Chairman, TOFTigers

Eco-entrepreneur, ex safari operator, conservationist, guide and writer, Julian Matthews has dedicated his last fifteen years to the plight of the tiger and its forest

home in the Indian subcontinent. Born and brought up on a farm in Zimbabwe, he saw first-hand the rewilding and rejuvenation of Southern and East Africa through the boom in safari tourism in the 1980's and 90's.

Today, having walked and travelled across huge swathes of India's once mighty forests, run numerous safari and walking tours with his own nature and safari travel business, he set up a charity called TOFTigers, as a tiger conservation tool to drive better nature tourism across the Indian subcontinent, modelled on the best examples from around the world. Today is has over 300 travel companies involved from across the globe, and he highlights 'Tigernomics' as one of the key pillars on which it can save its wildlife and forests.

TOFTigers today runs the only wilderness based certification system in South Asia, the PUG certification, with over 85 lodges involved across 26 wilderness destinations in both Indi and Nepal. It recently launched a new Tour Operator certification to help drive sustainability and conservation efforts across the sector.

Kathleen Pessolano is Director of the GSTC Destinations Program.

Kathleen is an attorney and international practitioner at the intersection of tourism

and sustainable development. She assists destinations with planning, policy, and management systems to develop tourism while protecting the natural and cultural resources loved by visitors and residents alike.

With partners in OARS and her husband, she developed an ecotourism operation called Rivers Fiji.

Dr. Kim Langmaid is the Founder and Vice President of Sustainability Programs at Walking Mountains Science Center in

Colorado's Vail Valley. Kim played a lead role in the creation of the Actively Green GSTC "recognized" industry standard, the Mountain IDEAL GSTC "recognized" destination standard, and assisting Vail, Colorado in becoming the first certified sustainable destination in the United States.
